Privacy Policy

About this Policy

EVA is committed to protecting the privacy of any personal information held about individuals in accordance with applicable laws. "Personal information" is information about an identifiable individual, or an individual who is reasonably identifiable, as defined by applicable law. This policy describes the way in which EVA collects, holds and discloses your personal information.

Why does Executive Virtual Associate collect my personal information?

EVA collects and holds your personal information to allow us to perform our business function. What personal information does Executive Virtual Associate hold?

During the course of our business, we may collect personal information from you.

- Payment details (e.g. bank account / credit card numbers)

If you don't provide personal information?

If you can't (or won't) provide EVA with the personal information it reasonably requires, we may be unable to provide you with services you have requested.

How does Executive Virtual Associate collect personal information?

EVA will collect personal information directly from you. That collection generally occurs when you request a service or information about our services or access our website.

How does Executive Virtual Associate use my personal information?

EVA takes reasonable steps to ensure personal information it holds about you is protected from risks such as misuse, interference, loss and unauthorised access, use, destruction, modification or disclosure.

No data transmission over the internet is totally secure. As a result, any personal information you send to EVA over the Internet (including via email) is sent at your own risk.
